A net km/HUF unit charge applicable to the transport of a vehicle with a maximum weight of up to 3,5 t beyond the section boundary, i.e. to a location other than an expressway<sup>14</sup>, which is

- the net unit price per kilometre valid up to the section limit in addition to the unit rate as an exit fee (basic fee) in accordance with Annex 1 to Decree 30/2024 (VIII. 22.) of the Ministry of Construction and Transport;
- includes toll and continuous standby fee;
- excludes VAT and surcharges (weekend and night);
- shall be charged for the total number of kilometres travelled from (without) the section boundary to the agreed transport address/place and from there to the section boundary.
